- All tenants must be of eligible classes

Photography (for hire):

- Studio, video, drones, instruction, events

Professional offices:

- Doctor, lawyer, insurance agency, real estate, dentist, chiropractor
- Professional liability – see LocalEdge Specialty

Convenience store/ gas station:

- Including car wash and auto repair
- Appropriate security features

Pet care:

- Small domestic animals only
- Veterinarian, grooming, and boarding (Including mobile operations).
- No rescue or shelter activities or product manufacturing

Retail:

- Clothing, home furnishing, flooring, florist, electronics, art supply, musical instruments
- No tobacco, vape, guns, adult content
